RULES AND REGULATIONS OF THE KANTABANJI LIONS PUBLIC SCHOOL MANAGING COMMITTEE, KANTABANJI.

Definition : The society shall be called "Kantabanji Lions Public School, Managing Committee, Kantabanji".

Location : The registered office of the society shall be located At. Kantabanji, Dist.-Bolangir, Orissa.

Establishment : The society shall follow and be governed by the rules provided in the societies registration Act. XXI 1960.

Jurisdiction : It is jurisdiction in its own town shall not be extended with out the approval of the general body having 2/3 majority and also the same shall not be implemented without the prior approval of the add. Registrar of Societies with in two months from the date of passing such resolution.

Any person irrespective of cast and creed/Rich and poor subject to one who is a member of any of the Lion club of Kantabanji can become a member or as from time to time decided by the general body. The president secretary and treasurer of any Lions club of Kantabanji as decided by the General body from time to time shall be ex-officio members of the Managing Committee.

Managing Committee : It will consist of atleast thirteen members or as may be decided by the General body of the society and the management of the school shall be entrusted to this committee. The members so elected or selected to managing committee shall elect or select their chairman, Secretary and Treasurer for the better management of the school. If the General body thinks proper may elect or select member for the above posts.

Election : Election of the office bearers shall be made every 5 years/5 years as per the education code in the General body meeting and each member will be entitled to cast one vote only. The chairman shall have power of casting vote in times of need for decision making. Notice of annual General Body meeting will be also the notice of election.

the managing Committee shall meet once in a month and the General body shall be called at any time with one week notice.

Notice of the General Body shall be served before one week and emergent meeting can be called with 24 hour notice.

The quorum of the General Body shall be 1/3 of the total members of the society and the quorum for the managing committee shall be 2/3 of the total members of the society.

Office bearers : -
The Chairman shall be the Principal executive. He shall preside over the meetings of the society. In his absence a member so nominated by the remaining members present shall preside.

He shall be responsible to the General Body for proper charge and execution of its orders and resolutions regarding the proceedings of the meetings, exercise supervision over all the affairs of the school.
